AIRCRAFT LISTING AGREEMENT

We hereby accept the services of, grant and convey to USA Jet and Helicopter. (hereinafter USA) the exclusive right to list for sale and to solicit offers of purchase for a period of ninety days (90) days from the date hereof, the following Aircraft (hereinafter referred to as the "Aircraft"):

This Aircraft Listing Agreement shall endure thereafter until such time as one party shall give the other at least thirty days written notice of termination.

USA Jet and Helicopter to present all written offers to the Owner.

If USA Jet and Helicopter solicits a purchaser for the Aircraft and the closing with such purchaser occurs, the Owner agrees to pay a commission to USA Jet and Helicopter of * **% of the sales price or a flat fee of *** _____.

Any applicable sales taxes are not to be considered part of the selling price. In the event the Aircraft is sold within (6) months of the termination of this Agreement to a buyer introduced to the Owner by USA Jet and Helicopter, then the Owner shall pay USA Jet and Helicopter the same commission as set forth in this paragraph.

The Aircraft is to be sold by the Owner in "as-is" condition; with no express or implied warranties either with respect to merchantability or fitness made by the Owner. We agree to indemnify and hold USA Jet and Helicopter harmless of and from any and all liabilities, claims or demands resulting from the sale of the Aircraft, including any claim from warranties, representations express or implied made by any party other than USA Jet and Helicopter.

Owner shall maintain hull insurance on the Aircraft and shall cause the insurance carrier to waive any right of subrogation against USA Jet and Helicopter. USA Jet and Helicopter shall not be liable for any personal injury or property damage arising in connection with operation of the Aircraft if the Owner is operating the Aircraft. USA Jet and Helicopter, its employees and agents, shall not be liable to the Owner for any loss or damage to the Aircraft unless caused by USA Jet and Helicopter, including loss of use thereof, or to the business of the Owner and the Owner waives and releases its right of recovery against USA Jet and Helicopter for any such loss.
